TEMPORARY ORDER AGREEMENT

Now on this 14 day of March 2016, the above-captioned cause comes on for Temporary Order Hearing on Petitioner's Application for Temporary Orders and Respondent's Counterclaim to Petitioner's Application for Temporary Orders. Petitioner appears in person and by and through her attorney of record, James R. Gotwals of James R. Gotwals & Associates, Inc. Petitioner appears in person and by and through his attorney of record, Michael James King of Winters & King, Inc. The parties, having reached a Temporary Order Agreement in this matter as to all issues herein, hereby submit this Agreed Temporary Order for the review and approval of the Court.

WHEREUPON, the Court, having examined and considered the pleadings, court records, and being fully advised of the premises, the Court **FINDS** and **ORDERS**:

1. Petitioner and Respondent are awarded temporary joint custody of the parties' minor child. The Parties shall employ a 2-2-3 day schedule for temporary physical custody of the minor child. The parties shall alternative physical customer of the minor child as follows:

Mon-Tues ██████████

Wed-Thurs ██████████

Fri-Sat-Sun ██████████

The following week

Mon-Tues [REDACTED]

Wed-Thurs [REDACTED]

Fri-Sat-Sun [REDACTED]

The parties shall alternate weeks as set forth above.

The parties shall alternate physical custody of the minor child during the holidays as set forth in the attached Holiday visitation schedule.

2. Neither party shall expose the minor child to any third party with whom he/she may be romantically involved unless both parties have discussed and agreed in writing that it is appropriate.

3. The parties shall exercise the right of first refusal when a party exercising physical custody is unavailable for a period of greater than 4 hours, then that party SHALL offer the opportunity to care for the child during that period to the other parent.

4. Respondent shall pay Petitioner \$2,000.00 per month as child support on the 5th of each month. No child support computation is provided in that the parties' combined income exceeds the Oklahoma Child Support Guidelines.

5. Petitioner is temporarily awarded the following real and personal property:

- a. Petitioner's vehicle – 2015 Range Rover
- b. The personal property in Petitioner's possession

6. Respondent is temporarily awarded the following real and personal property:

- a. The marital residence 13410 S Lewis Ave., Bixby, OK 74008
- b. Respondent's vehicles 2014 Porche GTS

2014 Porsche Turbo S

2014 Ford Raptor

2016 Dodge Hellcat

c. The personal property in Respondent's possession

7. During the pendency of this Temporary Order, Petitioner shall pay the following items of debt:

- a. All debt and expenses associated with her residence
- b. All debt and expenses incurred by Petitioner since the filing of the Petition, unless otherwise stated in this Order
- c. All debt and expenses associated with the personal property temporarily awarded to Petitioner, unless otherwise stated in this Order

8. During the pendency of this Temporary Order, Respondent shall pay the following items

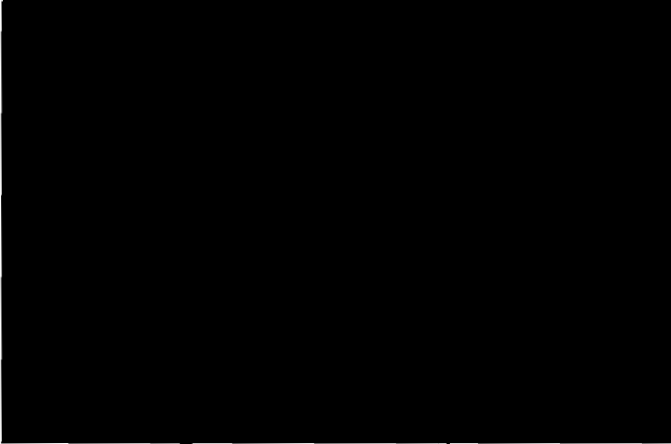
- a. The Mortgage on the parties' marital residence
- b. All debt and expenses incurred by Respondent since the filing of the Petition, unless otherwise stated in this Order
- c. All debt and expenses associated with the personal property temporarily awarded to Respondent, unless otherwise stated in this Order
- d. All debt and expenses associated with Petitioner's vehicle
- e. The parties' health insurance premium
- f. Credit expenses of Petitioner on the American Express Card # _____ in an amount not to exceed \$500 a month

9. Respondent shall pay Petitioner \$6,000.00 per month as temporary support alimony on the 5th of each month. The issue of taxability of the \$6,000 support alimony payment is reserved for later determination.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by this Court that the FINDINGS of this Court with respect to all matters therein set forth be and the same are **ORDERED, ADJUDGED AND DECREED** as fully as if hereinafter set out in length and are hereby made the ORDER of this Court.

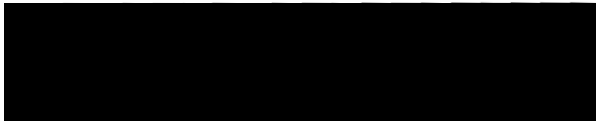
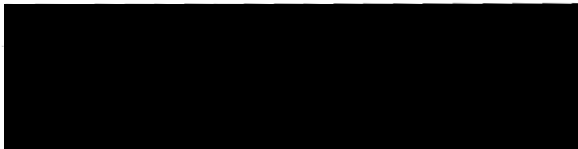


