PETITIONER'S MOTION TO DISBURSE PURGE FEE


COMES NOW Petitioner [Redacted Name] by and through her attorney of record, Natalie S. Sears of CORDELL | CORDELL, and for her Motion to Disburse Purge Fee, submits the following:

1. This Court has proper jurisdiction of the parties and the subject matter herein.
2. On January 24, 2017, a private arraignment was held on a Citation for Contempt filed by Petitioner against Respondent for numerous violations of Court Orders, including failure to pay child support.
3. On May 9, 2017, Respondent failed to appear on the Citation for Contempt action, and a bench warrant was authorized in the amount of \$6,821.75.
4. On July 18, 2017, Respondent appeared in Court on another matter set before this Court, and a purge fee hearing was conducted. A partial purge fee was set at \$1,500.00, cash bond, before this Court.
5. On July 18, 2017, the partial purge fee of \$1,500.00 was paid to the Tulsa County Court Clerk by or on behalf of the Respondent herein.
6. Petitioner requests an order from the Court releasing and disbursing the purge fee.
