**RESPONSE TO RESPONDENT'S APPLICATION FOR CITATION FOR

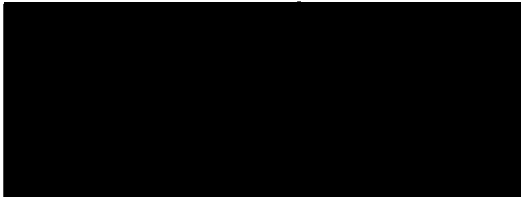
